

MINUTES OF THE MEETING REGARDING BADP HELD ON 12-06-2012 AT THE CHAMBER OF DM & COLLECTOR, KHOWAI DISTRICT: TRIPURA.

At the outset, Smt. Tanusree Debbarma, IAS, DM & Collector, Khowai District, welcomed all the participants and initiated discussion on action plan of BADP projects for the year 2012-13. After detailed discussions the following decisions were taken: -

1. The approved project list of BADP for the year 2012-13 has been circulated amongst the implementing agencies. As such, the BDO's and E.E.RD Div-III, Teliamura, are to initiate preparation of estimates and selection of sites etc. The preparation of estimates and site selection should be completed and submit to this office by 26th June 2012 positively by all implementing agencies.

Action by: - BDO, KHW/PDL/TLS & E.E. RD DIV-III, TLM.

2. The Executive Engineer, RD Division-III, Teliamura, is to prepare estimates for all sub-centers with Rs. 12.5 lakh only.

Action by: - E.E. RD DIV-III, TLM.

3. I/O for all works shall be appointed by BDO's. Only the works of Road to Ujjan Maidan shall be taken up from the end of EE. RD Div-III, Teliamura.

Action by: - All BDO's & E.E. RD DIV-III, TLM.

4. The Executive Engineer, RD Division-III, Teliamura, is also to prepare estimates for Multipurpose Community Hall at Block Head Quarter, Padmabil.

Action by: - E.E. RD DIV-III, TLM.

5. The Executive Engineer, RD Division-III, Teliamura is also requested to prepare estimate for formation of road from NEC road to Ujan Maidan.

Action by: - E.E. RD DIV-III, TLM.

6. The BDO, Padmabil is to convene meeting regarding development of destination point at Ampura.

Action by: - BDO, PDL.


7. The Chief Whip of Tripura Legislative Assembly, local MLA, SDM, Khowai, E.E. RD Division - III etc. should be invited in the meeting and jot-down the components essential for making the place tourist centric.

Action by: - BDO, PDL.

8. 3 nos. sub-centers namely, Khirodhnagar, Shantinagar & West Takchaya in Padmabil, Khowai and Tulasikhar Blocks respectively are still not tied up with BADP or NRHM schemes. The BDO's may send proposal immediately.

Action by: - BDO, PDL/KHW/TLS.


