

**MINUTES OF THE MEETING HELD ON 20-04-2013 AT 10.00 A.M IN THE CONFERENCE HALL OF DM & COLLECTOR, KHOWAI DISTRICT IN CONNECTION WITH REVIEW OF STATUS OF BOARDER FENCING ETC.**

DM & Collector, Khowai initiated discussion. The following points were discussed.

1. Concreting of only 80 Mtr. out of 800 Mtr. unfenced border in Khowai Town so far completed, as reported by Sr. Manager, NPCC. He assured that by 30/06/13 it will be completed fully.
2. As regards fund, it was intimated by Sri C. Kamaraju, Manager that LAC Dhalai is having surplus fund and therefore Land Acquisition Proposal may be sent to the Govt. for notification U/S 4 of LA, Act.
3. Trijunction at Chachundar Nala: Area should be illuminated by flood light since the area is critical and BSF should take measure for strengthening of the parties at the post.
4. Taking part in discussion, SP Khowai intimated that Box Culverts on IBB fencing are to be covered by barbed wire to check any illegal entry through the box culvert. He also requested that publicity of 144 Cr. PC, promulgation is to be done for information of the common people.
5. NPCC officials shall ensure completion of erection of flood light posts in the unfenced area in Khowai Town for lighting system. Special steps should be taken for uninterrupted running of Generator etc.
6. SDM Khowai reported that some theft cases have occurred in Khowai Town area in recent past and therefore BSF officials should ensure deployment of more parties in

unfenced areas for stopping border crimes. He also reported that fencing in different part required maintenance. Hence Executive Engineer, CPWD, IBBR (M) Division, Usha Bazar Agartala Airport be requested to undertake the work on priority basis.

The members present in the meeting visited the unfenced area of Khowai Town after the meeting.
