

**Tour Note of Ms. Tanusree Deb Barma, IAS, District Magistrate & Collector,  
Khowai in connection with visit to SDM Office, Teliamura on 12-07-2012.**

I visited SDM Office, Teliamura on 12-07-2012 to attend a meeting with the inhabitants of Amar Colony under Kalyanpur Block. Information in relation to this issue was communicated to Revenue Department vide my earlier tour note No.6728-35/F.III(64)-DM/KH/REV/2012 dated 17<sup>th</sup> April, 2012. In this meeting SDM, Teliamura had called those parties (approximate 124 families) who are presently occupying the land of some other allottees since the time of ethnic clashes in the 2002-03. They had been allowed to take shelter and establish their homesteads by the actual land owners allottees on the condition that they would return to their villages when situation would permit. However, after a decade, the 124 households of Amar Colony are now praying that they are totally dependent on the local economy for their livelihood and would want continue staying here. The Note of the SDM, Teliamura is enclosed. The decision taken in the meeting are given below:

- (1) All the occupants of Amar Colony agreed to shift their houses to a location that shall be identified by the Revenue Administration. SDM, Teliamura informed that a compromise has been struck between both the parties. As per their mutual agreement, a compact land would be identified for relocating these families with homestead land and pathway etc out of the previously allotted land. The allotments against these lands would be cancelled. The land that would be vacated shall be reallocated to the present land owners/allottees proportionately.

**[Action: SDM, Teliamura]**

- (2) SDM, Teliamura reported that he had also conducted meetings with the allottees i.e. persons whose land the inhabitants of Amar Colony were staying on for last 10 years. They have agreed that they shall allow some of their owned allotted land to be allotted to these families provided they vacate the balance portion. SDM, Teliamura shall report regarding the exchange formula **within August 30<sup>th</sup>, 2012.**

**[Action: SDM, Teliamura]**

- (3) As many of these inhabitants of Amar Colony landless and homeless BPL families, a separate proposal for giving them benefit of IAY house shall be initiated. BDO,

Kalyanpur may draw the process for identification of eligible families immediately. For those that shall not be covered from the Block from the IAY waitlist, special proposal shall be initiated for approval of the Government.

[Action: BDO, Kalyanpur]

**Discussed with the SDM, Teliamura regarding his Cash Book:**

(1) SDM, Teliamura shall ensure that the old entries in his Cash Book shall reduce from 148 to 110 excluding new entries within one month.

[Action: SDM, Teliamura]

(2) He shall make sure that amount still unspent in relation to CLR, E-subhidha, A/C etc. shall be spent following of financial rules and procedures and removed as unspent entries in his Cash Book.

[Action: SDM, Teliamura]

(3) An unspent amount related to repair and maintenance of Madrasa, Mosque etc shall be immediately utilized.

(4) Bill entries of years before 2010 may be examined by him and he should put up a Action Plan for spending the money.

[Action: SDM, Teliamura]

(5) Discussed with SDM, Teliamura regarding land acquisition issues related to irrigation project, road and bridges.

(a) **Irrigation Project:** Ghilatali land acquisition completed. Money has been taken by awardees but canal was obstructed at various locations by the locals. SDO, Water Resource and Executive Engineer, Water Resource had been requested to take action regarding the people's demands so that the project can start functioning immediately and the additional work of 1.5 km extension of canal can also start.

[Action: EE/SDO, WR, Agartala/Teliamura]

(b) **Road & Bridges:**

(c) **Kalyanpur Bridge:** All issues have been resolved with respect to handing over of approach road to PWD.

(d) **Mahorcharra Bridges**: 7–8 persons are obstructing the approach road saying that they should get compensation as per new valuation chart. SDM, Teliamura put up report immediately. On the Kalyanpur side tribal owners allegedly did not share the award money with non-tribal possessors as per their agreement and there is problem in vacating the approach road.

[Action: SDM, Teliamura]

(e) **Bagan Bazar**: Land acquisition is pending and L.A. Collector may take immediate action.

[Action: L.A. Collector]

(f) **Baishgaria**: Land acquisition has not been provided. L.A. Collector may take necessary action.

[Action: L.A. Collector]
