Subject:-Observation of functioning of Angan Wadi Centers (AWC) visited on 2nd July,2012.

Sir,

I am bringing to your kind notice the status of functioning of few AWC that where visited by the undersigned on 02.07.2012. You are requested to take necessary action against each observation and **report within the 18.07.2012.**

1. Laltilla Angan Wadi Center:

- Angan Wadi Worker (AWW) was not present.
- Angan Wadi Helper (AWH) informed that she generally does not attend the Center on the date of monthly meeting with the CDPO.
- Since the monthly meeting starts at 11.00 a.m., the AWW may be directed to attend the Center and then attend the meeting.

2. Basundara Angan Wadi Center:

- Only 2 children attended the center today. 22 children had attended the center on 30.06.2012.
- Checking the attendance register it was found that the attendance have been at least 18 and maximum 22 throughout the month. AWW informed that Supervisor Ms. Laxmi Bhattacharjee regularly inspects the AWC but I could neither inspect the growth chart nor the feeding register as the worker reported that she had left it

at home. You may kindly direct all AWWs to maintain register's in order and to make them available at the center so that it can be checked by district level officers during the working of the AWC.

- The Kitchen shed needs repair & maintenance and you may request the BDOs to take up the work. The Toilet of AWC has been made 6 months back but is not being used. There is water available within the premises, therefore there is no justifiable reason for non- utilization. You may direct all AWW to utilize the new toilets that have been constructed and inculcate good sanitation practices among the children. Necessary order may be issued accordingly.

3. Nandi Para Angan Wadi Center:

- 10 children were found to be attending the AWC. 15 children had come yesterday.
- The floor of the AWC needs repair & maintenance and there is an old Kitchen shed where the SNP meal is being prepared.
- There is one child namely Ayushma Das who is on the border line of being marasmic. You are requested to ensure that this under weight child is given necessary medical attention.
- The ASHA workers performance was appreciable.

4. Surjya Krishna Angan Wadi Center:

- The AWC is being conducted in a newly constructed building. Toilet has been constructed but there is no door affixed as yet.
- There is water a point (Mark-II/OHP) within the premises. SDO, Water Resources, Khowai may be asked to take up necessary repair & maintenance.
- No growth chart register is being maintained.

5. Kamini Para Angan Wadi Center:

- 15 children were present today. Checked the feeding register. There are about 60 Kgs. Rice found in excess. Supervisor may be asked to bring this excess rice forward to the opening balance of next month so that it is not misused.

- The toilet has been constructed but GCI roof is broken, you may take up the matter with the concerned BDO. Building for the new AWC is ready. Only grill painting is required. You may ensure that the AWC starts functioning in the new building.

6. Muslim Para Angan Wadi Center:

- The AWW did not attend the center today.
- No toilet has been constructed for the AWC. There is no Kitchen shed also in the AWC.
- I could not check registers.
