

4. The undersigned reserves the right to accept or reject any tender including the highest bidder without assigning any reason thereof.

5. Bids are liable to be rejected summarily for not fulfilling any of the conditions given below:-

TERMS AND CONDITION

1. No bid will be accepted without earnest money.
2. Rate offered should be written both in figures and words.
3. The successful bidders shall have to deposit amount within 07(seven) days from the date of issue of the acceptance letter and arrange to remove the materials within 03(three) days from the date of depositing the bid money, failing which earnest money will be forfeited.
4. Sale tax or any other tax, if applicable as per rules shall have to paid by the successful tenderer to the appropriate taxing authority and the documents of such payments should be submitted to the undersigned within 07(seven) days from the date of acceptance of the tender along with the tender value.
5. Earnest money of the 1st, 2nd & 3rd highest bidder will not be released till delivery of the vehicle and that of the other will be released after the selection of the 1st, 2nd & 3rd highest bidder.
