

- Deposit at call for Rs.1,000/-


TERMS & CONDITION:

If the suppliers fails to supply the item as per requirement within 7(Seven)days, the money as deposited in the shape of Deposit at call will be forfeited.
- Successful quotationer will have to supply the ordered material as per specification. No interior or duplicate materials will be entertained by this office. In case of such supply the D-Call Money(Security Deposit) will be forfeited as usual course.
